



ACCOUNTING SYSTEMS – WHAT ARE THEY AND HOW DO I SELECT THE RIGHT ONE FOR MY MARIJUANA BUSINESS?

An accounting system is a program that automates financial activities, centralizes financial data, and streamlines overall accounting operations. It can also automate tasks such as invoicing, bank reconciliations, accounts payable (A/P) functions, accounts receivable (A/R) functions, and more. Its purpose is to help avoid costly bookkeeping mistakes and allow your employees to be more efficient.

Choosing the right accounting system is essential to the productivity of your company. Elements to consider are functionality, system type, and cost.

Functionality elements to consider include, but are not limited to:

- Specific operations you may want in your system such as payroll, financial reporting, inventory management, A/P, A/R, invoicing, etc.
- Desktop (network server) or Cloud-Based (internet)
- Ease of use - installation and day-to-day
- Scalability – can the software grow with you?
 - How many users now and possibly in the future?
 - Customizable to add features later?
- Compatibility with existing software and programs your company uses
- Double-entry bookkeeping (every transaction is recorded in 2 accounts (debit one/credit other))

System type refers to the size and number of built-in functions an accounting software has at the basic or lowest price option.

- Payroll and Accounting Management Systems (for smaller/start-up businesses)
- Billing & Invoicing Systems (can be add-on to above or stand-alone)
- Enterprise Resource Planning Systems (ERP) (typically for larger companies)
 - Contains, but is not limited to, financial planning, inventory management, distribution, marketing, human resources, eCommerce, and customer relationship management (CRM) modules

Lastly, the total cost of the accounting system should be considered. This includes installation fees, monthly subscription fees, per user fees, technical help fees, etc. Many systems offer tiered pricing options and it's also important to note that modules such as payroll, A/R, or A/P usually cost extra.

A successful choice in accounting system starts with planning and research. Know your company's industry requirements, internal expectations, and take advantage of software trial periods.

Your CPA can typically provide insight into a variety of different systems and help you make the best selection based on the specific needs of your business. Consider getting them involved early in the selection process.
